# General Information

## Office and School Hours

The Calvary Chapel Christian School office is open from 8:00 a.m. to 4:00 p.m. during the school year. Summer hours for the office are 9:00 a.m. to 4:00 p.m. The office phone number is (585) 398-2218. The fax number is (585) 398-3250.

Classes begin daily at 8:15 a.m. and end at 2:45 p.m. Seniors and those riding busses are dismissed first. Students being picked up by parents are dismissed at 2:50 p.m. (Students should not remain after 3:30 p.m. unless involved in a supervised activity.) The building is opened at 7:30 a.m. and closed at 5:00 p.m.

## Guidance

The school is pleased to offer guidance services for our Junior High and Senior High students for course selection, required credits, and college testing information. All questions should be directed to our counselor Debbie VanScott.

## Attendance

Students are expected to be in attendance every day unless they are ill, have a family emergency, or have a prearranged **excused** absence. Other reasons are considered unexcused. If a student will be absent, the parent should notify the school office that day by 9:00 a.m. Every absence or tardiness requires a signed note from a parent upon return explaining the reason for the absence. After three **unexcused** absences or tardinesses, an after-school detention may be given.

Students are expected to be in attendance 90% of the time. Therefore, students who are absent more than 21 days in the school year may not advance to the next level.

## Accounting

Tuition may be divided into 11 equal monthly payments. Tuition billing is done in advance, the Initial Payment is due July 10<sup>th</sup>, the September tuition (payment 2) is due August 10<sup>th</sup>, October tuition (payment 3) is due on September 10<sup>th</sup> and so forth. For those who pay the entire year in advance, there is a 5% discount if all tuition is paid by August 1<sup>st</sup>.

All accounts are expected to remain current. Payments are due 30 days after the invoice date. In order for students to begin a school year, their Initial Payment (due July 10<sup>th</sup>) and September tuition payment (due August 10<sup>th</sup>) must be paid.

***Should tuition be unpaid 60 days after the invoice date, 10 additional days will be granted to make payment in full. If payment is not made in full by the tenth day, your child or children will be unable to attend CCCS until payments become current.***

Quarterly report cards will be held if tuition accounts are not current. At the end of the school year, diplomas, final report cards and transcripts will not be released until **all payments** and **all absence/tardy excuses** have been received. Students may not begin a new year at CCCS if the previous year's payments have not been completed, and the first 2 payments completed for the new school year.

## **Withdrawal**

If a student withdraws from Calvary Chapel Christian School by September 1<sup>st</sup>, all fees and tuition payments are completely refundable. After this date the Initial Payment is not refundable. If a student is later voluntarily withdrawn or dismissed due to discipline, the full tuition for that month is still due. ## **Health Procedures**

Our school nurse is Joan Griffin. Mrs. Griffin should be notified of medications that your child will be taking during school hours. A completed Medication Form, signed by a parent and physician, must be given to the school office before any medication may be distributed. All medications should be brought to the school office by a parent. Medication will be stored in a locked cabinet, and then distributed to the student at the appropriate time by Mrs. Griffin.

Students are **not allowed** to carry medication of any kind, including “over the counter” medications. There are some exceptions, however. A student with asthma may carry an inhaler if a parent and physician have signed and turned in a Self Medication Form stating that the student has been instructed on how to administer his or her own medication. Self-medication is determined by the severity of the health problem. All forms may be obtained at the school office.

## **Cell Phones**

Cell phones and are now quite common with students and have become a form of amusement and are a distraction! **Therefore, cell phones, must be put away and out of sight from 7:30 am to 3:00 pm.** (Students are also not allowed to take pictures with their cell phones during this time). **If students need to make a call, they may use the pay phone in the Chapel Store. If it is deemed necessary by the administration, they may come to the school office, and will be allowed to use an office phone. Parents who wish to contact their child should call the school office.** Should a student become sick during the school day, the school nurse will call home.

First Offense: Cell phone will be returned to the student after school.

Second Offense: Cell phone will be returned to parents only.

Third Offense: Cell phone will be returned to parents at the end of the school year

## **Walkmans/iPods/Electronic Devices/Skateboards/Books**

Walkmans, iPods, radios, and CD players with headphones, video games, or *other electronic devices* (with the exception of math-only calculators) are **not allowed** for use **during school hours (school officially ends at 3:30 pm) or on school field trips or at any school activity such as athletic practices, games (home or away), plays, history fairs, etc.** (These devices may contain material that is inappropriate). Laser lights are also not allowed during school hours or at school events.

**Consequences for not abiding by this will be the same as for cell phones.**

To ensure the safety of students and staff members, **skateboards, roller blades and roller skates** may not be used during school hours, prior to 3:30 pm. For insurance reasons, those who use skateboards, roller blades and roller skates after 3:30 p.m. must wear helmets!

We also do not allow students to bring in music, books or magazines which have not been pre-approved.

## **Eighteen Year Old Students**

Calvary Chapel Christian School students who have reached eighteen years of age are expected to continue to live under the supervision of parents or legal guardians. Should a student move from home to live apart from parental supervision, he or she would be asked to withdraw from CCCS. Students who are married are also unable to attend CCCS.

## **Homework**

Students absent due to illness, excused absences, suspension or other valid reasons will be allowed to make up all missed work. **The responsibility for missed work lies totally with the student.** Generally, one day for each day absent should be allowed for the completion of the work.

## **Promotion Policy**

Students must pass all required courses each year in order to assure promotion to the next grade. Required courses are Bible, English, history, math and science. A student who fails any of the required courses must make it up in summer school or repeat it again next year in order to move on to the next grade.

## **Standardized Testing**

Stanford Achievement Tests will be administered to students every other year. These tests allow the school to assess our curriculum and student progress. This year we will test grades 6-11 in the spring.

## **College Preparation Tests**

CCCS encourages all Juniors to take the SAT and the ACT. These tools used by colleges to assess the ability of college candidates. These tests may be taken multiple times in order to gain the highest scores possible.

## **Spiritual Life and Conduct**

Each student should understand that attending CCCS is a privilege granted to those who will demonstrate a spirit of harmony with the philosophy and goals of the school. By attending CCCS, the student indicates the desire to become a sincere, cooperative member of the student body. This is important in order to provide the best possible setting for growing spiritually, physically, socially and academically.

Spiritual life is never the result of superimposed rules, therefore the CCCS standards of conduct are not designed merely to produce a pattern of outward conformity. **Our school desires that students demonstrate, by their conduct, an inward acceptance of Christ and an attitude of submission to His Lordship.**

**While attending CCCS, all students are expected to follow the guidelines stated herein 365 days a year, on and off campus!**

## **The Christian Lifestyle**

Students are expected to live by a standard of behavior that is consistent with the Word of God. While enrolled at CCCS, students must at all times refrain from:

- 1) Drug or alcohol involvement or possession
- 2) Possession of a weapon or dangerous object (gun, knife, etc.) on campus.
- 3) Sexual misconduct, pornography
- 4) Extreme insubordination or disrespect
- 5) Fighting or physical harassment
- 6) Verbal harassment (excessive teasing, gossip, slander, lying, etc.)
- 7) Stealing
- 8) Vandalism
- 9) Profanity, vulgarity (written or verbal)
- 10) Cheating
- 11) Smoking or possession of tobacco

Students who violate these standards will be subject to disciplinary consequences, which may include dismissal from school. Students should also make every effort to avoid compromising situations that might give the appearance of being involved in the above activities.

Violation of the list above, whether before or after school hours, on or off campus, may result in immediate suspension or expulsion. The consequences will be applied at the discretion of the school administration, as the Lord leads.

**Choosing to allow these behaviors in your life  
is to choose to attend school elsewhere!**

## General Standards

In developing self-discipline, students shall be responsible for their own behavior. They are expected to obey all the rules. In the interest of creating an orderly environment and wholesome atmosphere, the following are not permitted:

- 1) Tardiness to class
- 2) Class disruption (talking, rowdiness, etc.)
- 3) Infringement on the rights or safety of others
- 4) Failure to complete assignments
- 5) Chewing gum (gum is not allowed at the school, inside or outside the building during school hours, 7:30 a.m. to 3:30 p.m. Gum is also not allowed at after-hour school events).

The above infractions will result in lunch detention or after school detention. After school detention is from 3:00 p.m. to 3:30 p.m.

## Social Conduct

“All things are lawful, but not all things are profitable. All things are lawful, but not all things edify. Let no one seek his own good, but that of his neighbor.” (1 Cor. 10:23,24). “Abstain from all appearance of evil.” (1 Thessalonians 5:22). Scripture exhorts believers not to abuse their liberty in Christ. We are to behave in a manner that will not cause others to stumble or be hindered in their growth.

**Students’ personal relationships should be above reproach.** Young men and young women should be able to be friends without compromising each other’s integrity or reputation. The conduct of the older students has a great influence on the younger. They should at all times be mindful how their actions affect others. As a result, at school students will not be allowed to affectionately hold hands, kiss or hug.

We encourage friendships among students, but at school we discourage the “pairing off” of students of the opposite sex, especially in an exclusive way. Please remember that we are to be examples of the believer in our conduct and purity (1 Timothy 4:12). The staff and administration will deal with situations of inappropriate behavior on an individual basis.

## Positive Behavior

The following are things that we want to **encourage**:

- 1) Love Jesus! (Matt. 22:37; John 8:42).
- 2) Love one another. (John 15:12,13).
- 1) Patriotism – we will recite the Pledge of Allegiance in homeroom (K-12).
- 2) Ladies first – Boys are asked to let the girls go first. Show respect and courtesy. (Open the door, etc.).
- 3) Be an ambassador – Greet visitors when they come to CCCS.

## **Dress Code**

The dress and appearance of the students at CCCS should be consistent with the school's Biblical emphasis. Therefore, we seek to glorify our great God and Savior Jesus Christ in the appearance of our staff and student body. The following applies to the staff and students in K-12.

- 1) Dress should be characterized by neatness, moderation, and modesty.
- 2) Hats and hoods may not be worn inside the building. (Girls may wear bandanas, however. Calvary Chapel Lions hats may be worn inside on game days).
- 3) Shoes, boots, sandals or flip-flops must be worn, as students may not be barefoot. Shoes with rollers, and bedroom slippers are not allowed.
- 4) **Tank tops and sleeveless shirts/outfits may not be worn.**
- 5) **Low-cut, "revealing" tops are not allowed.**
- 6) **Shirts must cover the waist completely at all times.** *No skin should be showing when one bends over or reaches up. If the outer shirt is not long enough, then a longer undershirt must be worn to cover the skin at the waist.* (Please test this out at home!)
- 7) Shorts and skirts may be no higher than 3 inches above the knee.
- 8) No skintight clothing.
- 9) **No underwear showing.**
- 10) No pajamas.
- 11) No jewelry that requires body piercing, except earrings on girls. (no earrings on boys).
- 12) No painted hair with unnatural hair coloring.
- 13) No Mohawk style haircuts.
- 14) Writing on hands, arms or other areas of the body is not permitted.
- 15) No shirts, jackets, book bags, hats, etc., that advertise things that we do not believe glorify the Lord, such as secular rock groups, alcohol, sexual or offensive material, etc.

**\*The dress code is in force while students are at school, on field trips or at other school-related activities.**

If an outfit is in violation, the student will be sent to the office to wait for a change of clothing from home. A student will not be permitted back into class until appropriate clothing is available.

**Parents are asked to be proactive in monitoring what their children wear.**  
**If in doubt, don't wear it!**

## Food and Drinks

In order to keep our carpeting clean, students and teachers may **not** eat or drink in the lobby or hallways. Drinks with plastic lids (such as hot chocolate, or coffee) may **only** be carried from the café to a classroom during the morning break and lunch period. Sealed drinks, such as bottles or cans, may be transported from room to room at any time. Open cans may not be carried in the hall. **Students are not allowed to eat or drink while a class is in session.** Students are expected to properly dispose of their own wrappers, bottles and cans. Let's all help to keep the classrooms clean!

## Field Trips

Class field trips are intended for the students of the designated class or classes. CCCS students from other grades may not leave school to go on a field trip that is not intended for them. (In rare, unusual circumstances, the administration may grant exceptions).

We are grateful for parents who can drive for field trips! Field trip drivers are expected to help chaperone the class. Drivers may include any of their own children who are not enrolled at CCCS. (It is important, however, that the event is age appropriate for them and that they are well supervised.)

## Computer Use Policy

The **computer lab** is for the benefit of CCCS students, to use for God-honoring purposes. These purposes should relate to the church or school activities.

- Students may use the Internet only for the purpose of **research** for a class, college entrance or for other special purposes permitted by the school administration.
- Students may not use the computers to play music, games or other forms of entertainment unless directed to do so by the CCCS office. (Computer chess may be played).
- Students may not visit music websites. The only exception is a Christian website for worship music. The CCCS administration must first approve this site.
- Students may not use the computers for e-mail.
- Students may not use the school computers with a password other than their own.
- Students may not use the computer lab while a class is in session in the library.
- Students may not tie-in **laptops** to the church/school network.
- Because they are difficult to supervise, laptops may not be used during a class unless special permission is given. Laptops may be used in study hall situations. In school, they may not, however, be used for games and/or viewed by students other than the owner.

*Students who fail to comply with this policy will lose computer privileges and are subject to disciplinary action.*

*Library computer hours for students are 8:00 a.m. to 4:00 p.m., Mon.- Fri.*

## **Cheating and Plagiarism**

Plagiarism (to steal or pass off the words of another as your own) and cheating are serious offenses in school. Cheating includes:

- Looking at another student's test or quiz paper.
- Using a cheat sheet.
- Aiding or allowing cheating.
- Any form of communication during a test or quiz.
- Stealing a test or the distribution of a stolen test.
- Doing another student's homework, paper or project.

The consequences for cheating or plagiarizing are:

The first offense results in a zero on the quiz, test or paper and a teacher/student meeting with the administration.

The second offense results in a zero on the quiz, test or paper, a parent conference with the administration, and a three-day suspension.

The third offense results in expulsion.

## **Throwing Objects**

The throwing of a **snowball** could cause serious harm to its victim. Other thrown objects such as **apples, rocks, etc.** can cause just as much hurt. Therefore, the first throwing offense for a K-5 student is a detention (lost PE class for K), and for a 6-12 student is a one-day suspension. The second offense for K-5 is a one day suspension and for 6-12 is a three-day suspension. This applies to anything thrown outside or inside the building.

## **School Extra-Curricular Activities**

Students are encouraged to participate in the available extra-curricular school activities. These activities can be very valuable experiences to our youth, which are only available to them during their school years. More activities will be developed as the Lord leads and provides appropriate instructors and/or advisors. (Since CCCS is a part of Calvary Chapel of the Finger Lakes (CCFL), and supports the vision of the ministry, our teaching staff, head coaches, and club advisors are selected from CCFL members).

Students who participate in CCCS interscholastic athletics must maintain an average in each subject of 70% or better to be eligible. The monitoring of player averages will begin with the late September grade report. Players whose average falls below this mark may not practice or play until their grade has again reached 70%. This policy affects participation with Lions soccer in the fall, and Lions softball in the spring. Chess Club members who compete interscholastically must also maintain this standard as well.

## **Closed Campus**

Students are required to remain on the church/school grounds until the end of the school day. The exception would be for supervised class field trips or the participation in school athletic events. In all other cases, the parents must notify the school or be present in order for their child to leave school early. All students leaving early must sign out at the school desk.

## **Visitors (Shadowing)**

Student visitors are allowed at the school only by special permission. On the day of visitation, the visitor must go to the school desk to check in. The secretary will request a **parental permission note from the visiting student with a contact phone number.** Any visitors are also subject to the school dress code and other school rules.

## **Child Protection**

Under the **New York State Child Protective Service Mandated Reporter** section of the Child Protective Services Act of 1973, teachers and staff of schools and churches are considered MANDATED REPORTERS. If there is any suspicion of child abuse, the CCCS staff is obligated by law to report it. Of course, we pray that this situation will not arise. Should anyone desire counseling concerning this issue, pastors at Calvary Chapel of the Finger Lakes are available.
